# TOURNAMENT RULES

1. TOURNAMENT HOURS ARE SAFE DAYLIGHT TILL 3:00 PM
2. ALL BOATS MUST BE IN BUOY AREA BEFORE THEIR DESIGNATED TIME OR BE DISQUALIFIED.
3. ALL FISH BROUGHT TO THE WEIGH-IN (EXCEPT TROPHY BASS) WILL BE RETURNED TO THE WATER.
4. ONLY LARGEMOUTH, SPOTTED AND RED EYE BASS WILL BE WEIGHED.
5. MINIMUM LENGTH TO BE WEIGHED SHALL BE (12) TWELVE INCHES ON THE GOLDEN RULE.
6. ANYONE WEIGHING IN A FISH SMALLER THAN TWELVE (12) INCHES ON THE GOLDEN RULE WILL BE PENALIZED BY CULLING HIS OR HER LARGEST FISH – 2ND LARGEST FISH, ETC.
7. THERE IS A 5 FISH LIMIT PER BOAT.
8. NO TROLLING, JIGGERPOLING, LIVE BAIT, OR WADING. ARTIFICIAL LURES ONLY.
9. CONTESTANTS WILL ABIDE BY ALL APPLICABLE ALABAMA WATER SAFETY LAWS AND REGULATIONS.
10. CONTESTANTS WILL WEAR A LIFE JACKET AND HAVE A KILL SWITCH ATTACHED TO THEIR PERSON WHEN THE MAIN ENGINE IS RUNNING.
11. NO ALCOHOLIC BEVERAGES WILL BE ALLOWED ON THE LAKE.
12. FISH MUST BE BROUGHT TO THE WEIGH-IN AREA FROM THE DOCK, NOT FROM THE PARKING LOT.
13. NO REFUNDS WILL BE GIVEN ON THE DAY OF THE TOURNAMENT.
14. THE BIRMINGHAM BASS MASTERS RESERVES THE RIGHT TO DENY ENTRY TO THIS TOURNAMENT TO ANYONE FOR ANY REASON.
15. ANY TIES WILL BE DECIDED BY THE TOURNAMENT COMMITTEE.
16. ANY CONDITIONS ARISING WHICH ARE NOT COVERED BY THE ABOVE RULES WILL BE RESOLVED BY THE TOURNAMENT COMMITTEE, WHOSE DECISION WILL BE FINAL
17. PARTICIPANTS MUST BE AT LEAST 18 YEARS OF AGE OR HAVE PARENT/GUARDIAN SIGN ENTRY FORM.
